SECURITY MEASURES AT PSAP

OPCD is currently on schedule with security upgrades with the recent installation of proximity boxes at front and rear entrances of the PSAP. The installation of electronic gates will require all Communication personnel to have electronic swipe cards for entry through the gates and through the front and

back doors of the Communication Center. OPCD will provide all personnel with Identification cards and card holders. Visitors coming to the Center will be required to ring personnel to gain access through the gates. Entry into the building will require clearance from agency personnel.

Employees will be required to provide OPCD with their vehicle make, model and license plate number and social security number.

Replacement fee for lost or stolen cards is \$20. The processing of identification cards will begin July 16, 2007. 9-1-1 PSAP NEWS Page 2

NEW TRAFFIC REGULATIONS

The installation of electronic gates will directly impact the flow of traffic around the Communications Center.

FEMA Independent Study program offers several courses on line for first responders in communications. Incident Command training is being developed and offered for a variety of disciplines, including Federal Disaster Workers, Public Works, Law Enforcement, and Public Health.
